Gwen Simmons, Ed.D., North Carolina, has served DKG extensively including terms as Chairman of the International Constitution Committee, member of the Constitution Interpretation Committee, member of the team that prepared the revised 2010 Constitution, and member of the Committee that revised the *Society Handbook* creating the 2011 Go-To Guide. Simmons currently serves as Society Parliamentarian.

Simmons is a Professionally Registered Parliamentarian (PRP) and is currently serving a third term as Secretary/Treasurer of the NC Association of Parliamentarians and a second term as Parliamentarian for the NC State Organization of DKG. She has presented keynote speeches to various professional groups including DKG and has presented workshops on a variety of topics including, but not limited to, leadership (looking in the mirror for leadership), mission-oriented Chapters, basic Parliamentary procedure, writing minutes and developing BYLAWS.

Simmons has taught all educational levels, elementary through graduate school. Formerly Director of the Counseling and Testing Center of a State University, she now maintains a private counseling, coaching and consulting practice. Simmons has co-authored a book (2009) entitled See Jane Not Run ... Teachers are Leaders.

# WINTER - A time to: Celebrate - Reflect - Resolve to 'take on' new personal challenges AND ----Work Together to Make our Chapters even Stronger!

As part of our Northeast Regional Conference held in Portland, Maine, I attended and participated in **Dr. Lynn Schmidt**'s workshop entitled "It Doesn't Take Barbells to Strengthen a Chapter." I was so "invigorated" by the presentation that I simply couldn't wait to share the experience. I presented at the 2014 Spring Seminar and last summer's Presidents' Leadership Development. The program included easy access to a plethora of DKG diagnostic resources which Chapters could use to continually improve and grow their Chapters, thereby enabling them to become even stronger. Many of these documents may be accessed by using the Pi State DropBox. Presidents who were able to attend the President's Leadership Development Seminar and members who were able to attend the 2014 Spring Workshop or the 2014 International Convention in Indianapolis have access to these resources.

Some of the resources are: "Mandates for Chapters from the Delta Kappa Gamma Society Constitution;" "Moving Chapters Forward - Building Leadership Capacity in the Chapter;" "Four Stages of Team Building;" "Ten Strategies to Master Team Building;" and "Membership Basics from A to Z."

#### These and other resources serve as a basis for enabling Chapter members to develop plans for:

- a) Growing membership
- b) Increasing diversity within the Chapter
- c) Encouraging members to utilize their experience & expertise
- d) Analyzing best practices and increasing team building efforts
- e) Sharing our vision with others.

# The following were among the suggested and/or implied strategies for the development of an ongoing plan to strengthen and sustain Chapters in the future:

- 1) Analyze your Chapter's strengths and needs
- 2) Decide which area(s) to initially focus upon, including procedure(s) for increasing membership; having more diversity and inclusion; encouraging more members to participate to assume more leadership within the Chapter, and so on
- 3) Determine when, where and how to begin the planning process
- 4) Document Chapter findings (SAP)
- 5) Follow through and review annually.

Sharing and applying the planning strategies and collaboratively developing them within each Chapter, beginning with the 2015-2017 biennium, are priorities. The planning process for strengthening and "*invigorating*" our Chapters is ongoing. Some of our Chapters are further along in the process while others are just beginning. There may be some Chapters who have a '*carved in stone*' unwritten procedure which they think everyone in their Chapter knows. Whatever the case, I believe that engaging in conversation with Chapter members about the status of our individual Chapters, utilizing the talents and experience of each of our sisters, referring to and applying the suggested resources from "---Barbells---", and creating a documented plan which is reviewed and updated annually, will strengthen our current membership and ultimately assure our continuing growth in the future!



#### PROPOSED BYLAW CHANGES FOR 4.25.15

In accordance with ARTICLE XII Section A of the **BYLAWS of Pi** (New York) State of The Delta Kappa Gamma Society International, the BYLAWS & Rules Committee and the Pi State Executive Committee propose the following amendments to the **BYLAWS of Pi** (New York) State of The Delta Kappa Gamma Society International to be voted upon by the Pi State Executive Board and the Pi State Convention at their meetings April 25, 2015 in Uniondale, NY.

In addition to the following proposed changes, the BYLAWS & Rules Committee, in consultation with the Pi State Parliamentarian, reserves the right to make numbering and wording changes and to update the Table of Contents as is deemed necessary for clarity and ease-of-use.

#### 1. To amend Article III Section C by adding #3:

#### To Read:

#### The fee for State Organization and Chapter Honorary Members is \$49.50.

Rationale: This acknowledges that Pi State is in compliance with the 2014 International Standing Rules.

#### 2. To amend Article VI Section C 1 which reads:

The *Pi* State President shall call to order a meeting of the membership corporation at each State Convention or at a spring State Executive Board Meeting (non-Convention year) provided written notification is presented to the membership no later than the spring issue of *Pi Lights*.

#### By deleting spring and replacing with winter

#### To Read:

The *Pi* State President shall call to order a meeting of the membership corporation at each State Convention or at a spring State Executive Board Meeting (non-Convention year) provided written notification is presented to the membership no later than the **winter** issue of *Pi Lights*.

Rationale: This will give proper notification to all members with the submission date of December  $1^{st}$  for the winter issue of Pi Lights.

#### 3. To amend Article VI Section F 1a which reads:

The slate of officers, with candidate qualifications, shall be published in the spring issue of Pi Lights.

#### To Read:

The slate of officers, with candidate qualifications, shall be published in the winter issue of Pi Lights.

Rationale: This will give proper notification to all members with the submission date of December 1<sup>st</sup> for the winter issue of Pi Lights.

#### 4. To amend Article VII Section A 1 which reads:

Business of Pi State shall be conducted biennially at a Convention, in the odd numbered years, for the purpose of receiving reports, adopting policy, amending BYLAWS and Standing Rules, electing officers, and transacting other business. The time and place of the Convention shall be determined by the Executive Board.

#### To Read:

Business of Pi State shall be conducted biennially at a Convention, in the odd numbered years, for the purpose of receiving reports, adopting policy, amending BYLAWS and Standing Rules, electing officers, and transacting other business. The time and place of the Convention shall be determined by the State Executive **Committee.**

Any member, Committee, Chapter or Board shall be eligible to submit a proposed amendment. All proposals for amendment shall be studied by the BYLAWS & Rules Committee and recommendations shall be submitted to the Executive Committee for approval before they are published in *Pi Lights* and submitted to a vote at an Executive Board Meeting and a State Convention.

#### To Read:

All proposed amendments to these BYLAWS shall be submitted for study to the BYLAWS & Rules Committee by **November 1st** with a copy sent to the Pi State President. Any member, Committee, Chapter or Board shall be eligible to submit a proposed amendment. All proposals for amendment shall be studied by the BYLAWS & Rules Committee and recommendations shall be submitted to the Executive Committee for approval before they are published in *Pi Lights* and submitted to a vote at an Executive Board Meeting and a State Convention.

Rationale: This will give proper notification to all members with the submission date of December 1<sup>st</sup> for the winter issue of Pi Lights.

#### PROPOSED STANDING RULE CHANGES for 4.25.15

In accordance with Section 13 of the Standing Rules of Pi State (New York) State of The Delta Kappa Gamma Society International the BYLAWS & Rules Committee and the Pi State Executive Committee propose the following amendments to the Standing Rules of Pi State (New York) State of The Delta Kappa Gamma Society International to be voted upon by the Pi State Executive Board or the Pi State Convention at their meetings April 25, 2015 in Uniondale, NY.


