


Karen Jones is an adjunct faculty member for Empire State College, Mercy College, Adelphi University and College of Saint Rose.

Karen taught for forty years, thirty-four of those years working at Corinth Central Schools. In her career she has taught elementary classroom, middle school and high school reading and GED. In addition, she served as the K-3 Literacy Coach for six years and the 4-12 Literacy Coach for two years. She also chaired CSE and Preschool CSE meetings. She served as a curriculum development facilitator and provided after school professional development opportunities for teachers. Furthermore, Karen served as the district-wide AIS Coordinator and the District Reading Coordinator. She also served for over twenty years as Commencement Coordinator and Senior Awards Coordinator.

Karen received her B.S. in Elementary Education from New York State University College at Plattsburgh and her M.S. in Reading from University at Albany, NY. She has earned over 120 graduate credits. In addition to her N-K and Grades 1-6 and Reading Certifications, Karen is certified in Wilson Language Program Level I and Level II Upper Steps. She has served as President of and on the Board of Directors for Iroquois Reading Council. Furthermore, she is a member of *Beta Omega* Chapter of Delta Kappa Gamma Society International and currently serves as chapter president. In addition, Karen is the Educational Excellence chair for the New York State Organization of Delta Kappa Gamma. She is a member of NYS Reading Association, International Literacy Association, ASCD, and Phi Delta Kappa. She has presented workshops locally and statewide.

In 2004, Karen was named District Teacher of the Year. She has also been recognized for perfect attendance for eighteen years. Students recognized her work by giving her the Yearbook Dedication two times and Yearbook Appreciation eleven years. Karen also received the National Honor Society School Service Award three times and has been named to *Who's Who among America's Teachers* thirteen times.

Dr. Lucille (Lucy) Smassanow specializes in all areas of literacy instruction, Early childhood development, educating diverse leaders (including students with learning and/or behavioral needs), co-teaching and teaching English to New Learners (ENL). In addition, she scores written New York and Ohio teacher Literacy certification, School District Administration, and a variety of other teaching certification examinations for Pearson Publishing.

Lucy teaches both graduate courses and seminars for New York State United Teachers Education Learning Trust (NYSUT ELT). In addition, she has taught for the Graduate Literacy and English as New Learners Department at Mercy College, Dobbs Ferry, New York. She is a retired part-time Professor of Elementary Education, Literacy and Clinical Supervision at the State University of New York at New Paltz in the Hudson Valley. She has taught for the College of New Rochelle, Touro College of Literacy, PACE University as a Clinical Supervisor, and Sullivan County Community College in Early

Childhood Development. Lucy's educational credentials include a Ph.D. in Cultural Studies and Education with an emphasis in Literacy and educating diverse learners, M.A. in Cultural Studies and Policy with an emphasis in Curriculum and Instruction, and a B.A. in English Literature and Education with a minor in Art. She is permanently certified in English 7-12, Literacy 1-6, Elementary Education N-6, and School District Administration PK-12. She has taught and served on all levels in college, pre-kindergarten through senior high and adult education, and in both building and central office administration.

Lucy has written three books, one for teachers: *Think, Link and Learn for Literacy*, and two for children: *Grandma Goes Green* and *On the Way to Freedom*. Recently, as a visiting author, she was invited by Macy's Department Store, Reading Circle, Herald Square, NYC to read and discuss her book *Grandma Goes Green*.

Known for pioneering professional development workshops and seminars, Lucy has presented her original research on kinesthetic brain ignition teaching strategies for English Language Learners at Oxford University, Oxford, England.

On Friday evening April 26th, DKG Executive Director **Nita R. Scott** will share an update on the Society. During the Convention, she will present two workshops – the new dues collection process and a round table for Chapter Presidents. She will also install our new State Officers for the 2019-2021 biennium.

Nita R. Scott joined Society Headquarters in August of 2011 – serving first as Membership Services Administrator and now as Executive Director. Nita, an experienced educator, taught secondary mathematics and business in Tennessee and Arkansas before moving to Texas to work with DKG.

Initiated in 2005, Nita has served her Tennessee Chapter as President and as the Strategic Action Committee Chair. At the State Organization level in Tennessee, she was a member of the Membership Committee and served as Financial Advisor to the Convention Steering Committee. During her membership, she has conducted workshops at State Organization,

Regional and International Conventions. As a member in Texas, she has served on the State Organization Leadership Seminar and Membership Committees.

With a Bachelor of Business Administration (Marketing and Management) and a Master of Science in Education with a concentration in Educational Leadership, Nita uses data as a tool to enable Society leadership in marketing the Society and building membership. As a Certified Association Executive, she provides Society leaders with insight regarding best practices for non-profit association governance. While it was one of the most demanding work I've ever done, it was also the most rewarding and valuable professional development I've ever completed.

There are about 118,000 Board Certified Teachers in the United States. It is a symbol of excellence that empowers us to be the best teacher/educator we can be as well as opening doors to more professional opportunities.



PROTECTING THE VOTE

The very first act introduced in this session of Congress is For the People Act of 2019 (H.R.1). With 236 cosponsors it should pass the House in some form. The act sets forth actions which would protect the right to vote. The act has three categories 1) voting, 2) campaign finance and 3) ethics. It has been referred to several committees.

GREEN NEW DEAL

Legislation introduced in early February proposes a "Green New Deal." (H.Res.109 and S.Res.59) Within two weeks of its introduction the bills had 89 cosponsors in the House and 11 cosponsors in the Senate. The legislation apparently meets the approval of Senate Majority Leader McConnell who introduced S.J.Res 8 within a week of the introductions thus tying the two bills together. This joint resolution declares that the government has a duty to create a Green New Deal with the goals of:

- achieving net-zero greenhouse gas emissions;
- establishing millions of high-wage jobs and ensuring economic security for all;
- investing in infrastructure and industry;
- securing clean air and water, climate and community resiliency, healthy food, access to nature, and a sustainable environment for all; and
- promoting justice and equality.

The joint resolution calls for accomplishment of these goals through a 10-year national mobilization effort. The resolution also enumerates the goals and projects of the mobilization effort, including:

- building smart power grids (i.e., power grids that enable customers to reduce their power use during peak demand periods);
- upgrading all existing buildings and constructing new buildings to achieve maximum energy and water efficiency;
- removing pollution and greenhouse gas emissions from the transportation and agricultural sectors;
- cleaning up existing hazardous waste and abandoned sites;
- ensuring businesspersons are free from unfair competition; and
- providing higher education, high-quality health care, and affordable, safe, and adequate housing to all.

Notice the addition of "providing higher education." Although this bill doesn't mandate any action, it could be the basis for future legislation and/or suggestions such as replacing old school buildings or adding insulation, plumbing upgrades on older buildings. This legislation gives a look into how some members of Congress are working together. It also provides civics educators a way to explore the legislative process and look at the difference between a bill and a resolution. Even with the number of climate change deniers the resolution stands a good chance of passing; however, neither resolution sets forth a method for attaining the goals of the idea. Actually attaining the goals of the Green New Deal are not spelled out and will be difficult to achieve specific actions to attain these goals. Note that it does not make suggestions for action and does not provide any finding for making changes. That would have to come later and would be difficult to get done.

VIOLENCE AGAINST WOMEN ACT

There are currently three bills which relate to reauthorizing the Violence Against Act (VAWA). The Violence Against Women Health Act of 2019 (H.R.973) which deals with domestic violence and dating violence. The other two pieces of legislation are related to the Violence Against Women Act which expired in December

2018. H.R.1239 reauthorizes the Department of Justice programs which combat violence against women, and H.R.1310 would amend the Violence Against Women Act of 1994 to include the rural development voucher program. All three of these bills have been referred to committee, and none has been reported out of committee.

RECOMMENDED WATCHING

On the Basis of Sex, a movie about the life of Supreme Court Justice Ruth Bader Ginsberg (RBG) is being aired Sunday night at 8 p.m. cst on MSNBC. I think you would find it interesting. Not only does it document her life prior to being appointed to the Supreme Court, it shows her trials and tribulations in her early career and how she was helped and encouraged by her husband.

Pi State Education Foundation

The Pi State Educational Foundation is a tax-exempt organization that promotes literacy and learning by supporting literacy projects developed by NY State members and Chapters.

For this issue we are highlighting the inspirational remarks shared at our 15th Anniversary Celebration by our founding director and first Foundation president, **Agnes Becker**. We had asked Agnes to share with us her vision for the future, where she thought we might need to go in the future. While those of us in attendance were privileged to hear what she had to say, it's easy to forget the message. ALSO, there are hundreds across the State who were not in attendance to share Agnes' inspiring remarks. So, with her permission, here is what she had to say:

"The beginnings of the Foundation were slow and shaky. There were times when we didn't think it would survive. There were critics who said, "You will never make it with a one-time membership fee of \$25." The Board did all they could to encourage members to join and the numbers increased slowly.

Who would have imagined that since those beginning days, we would already have awarded \$28,340.66 in grants? Who would have imagined that because of grants we have awarded, hundreds of students have backpacks and hundreds of new parents have books for their babies with information about reading to them. Not to mention the creative music and math projects we have supported.

Two criteria for evaluating a Foundation are: Is the Foundation beneficial? Is the Foundation relevant? If, as the objectives state, the Foundation is to provide a tax-exempt means of making a charitable contribution and the Foundation will award grants to members and Chapters for projects that support literacy, I think we can say we have a successful, well-supported Foundation!

Looking to the future is never easy. Fifteen years ago, we were just hoping to survive. In the next 15 years, with the continued leadership and support, I think we have a good chance of flourishing. There will be challenges to face and opportunities to take advantage of. Some that I imagine are:

- * <u>How do you measure the Foundation's impact on literacy</u>? We depend on the teachers who are writing the grant applications and the Board members who are evaluating the potential of the grants. Having been a Board member, I know that members do their best evaluating proposals. The application asks questions that help to predict success. There have been times when the Board has not awarded proposals because they did not see how literacy was promoted.
- * How can the Foundation fit into the STEM efforts? How can we encourage more upper level educators to apply for grants? How do we help teachers of ELL?
- * Our BYLAWS state that the Foundation could award scholarships. <u>Is there an area or level of education lacking a possible DKG scholarship</u>?
- * Would it be possible to begin automatic donation deductions? Churches, radio and television stations and charities seem to have much success doing just that. You may not think to write a \$10 check every month but you may not miss \$10 a month from your checking account or added to your credit card balance. In the age of cut backs and failed budgets, DKG members should look to the Foundation to help finance those projects that they often support themselves. The Foundation was established for its members.

With the leadership that the Pi State Educational Foundation has now, the future looks very bright. I thank Ginny for her outstanding leadership and Jane, Grace, Jean and Sheila for the time and effort they give to the Foundation. Thank you, members, for supporting the Foundation."
