#### HISTORY OF LAKE PLACID

Lake Placid is known as the "Olympic Village" for many reasons. Lake Placid is one of the few areas to host two Olympic Games, the third Winter Olympics in 1932 and the thirteenth Winter Olympics in 1980. In addition, athletes from Lake Placid have participated in all but one Winter Olympic games and the community continues to host competitions at all levels. In a 1982 agreement with the state, all sports venues are operated and maintained for competition through the Olympic Regional Development Authority. Tickets to visit the venues are available through <a href="www.orda.org">www.orda.org</a>. The <a href="Olympic Museum">Olympic Museum</a> is available in the Olympic Center to learn more about this part of Lake Placid's history.

First settled as a farming community in 1800 when Elijah Bennett and family settled near the Chubb River and called this area "The Plains of Abraham." Early settlers also included Thomas Nash and Benjamin Brewster who settled on the shores of Mirror Lake (you can see a stone monument in their honor at the beginning of Main Street). The village of Lake Placid actually surrounds Mirror Lake, while Lake Placid (a much bigger lake with three islands) is located to northeast. The <u>Lake Placid Historical Society</u> hosts a museum on Station Street in the original railroad station where many tourists arrived.

The beauty of the Adirondacks was part of published writings and visitors came to enjoy the vistas and abundance of fish and game. The Nash family opened a hotel on the shore of Mirror Lake and offered boat excursions on Lake Placid and guides up Whiteface Mountain in the neighboring town of Wilmington. Some visitors settled in the area as state-owned land was available for pennies an acre.

Migration of free urban blacks occurred mid-century when generous abolitionist Gerrit Smith offered acreage for homesteads in a settlement called Timbuctu. John Brown, famous abolitionist, came north to assist these folks with developing farming skills. His home, farm, and final resting place can be found near the ski jumps.

The late 1800s saw the building of the first churches, post office, school, and library. The library, located in its original location on Main Street, is worth a visit. Many more visitor homes opened as Lake Placid became a popular early tourist spot. Most visitors arrived via stagecoach until the railroad began in 1893. Melvil Dewey, New York State librarian, was an early train arrival. In 1895, Dewey, an avid believer in the power of recreation, purchased a home, opened it up to friends, and this venture expanded into the famous Lake Placid Club. Once this was winterized in 1904, numerous winter sport opportunities led to winter sports vacations. Dr. Dewey's son, Godfrey Dewey, was influential in obtaining the 1932 Third Winter Olympic Games for Lake Placid and making sure the town had an arena, speed skating oval, ski jump, and miles of cross-country trails.

Kate Smith was a celebrity when she visited Lake Placid and decided to build her summer camp, Camp Sunshine, on the shores of Lake Placid. For years, Kate Smith's radio show was broadcast from her camp and her view inspired the song "When the Moon Comes Over the Mountains."

#### PROPSED BYLAW CHANGES FOR 5/1/2021

In accordance with ARTICLE XII Section A of the BYLAWS of New York State Organization of The Delta Kappa Gamma Society International, the Bylaws and Rules Committee and the New York State Executive Committee propose the following amendments to the BYLAWS of New York State Organization of The Delta Kappa Gamma Society International to be voted upon by the New York State Executive Board and the New York State Convention at their meetings April 30, 2021 in Lake Placid, NY.

In addition to the following proposed changes the Bylaws and Rules Committee, in consultation with the New York State Parliamentarian reserves the right to make numbering and wording changes and to update the Table of Contents as is deemed necessary for clarity and ease-of-use.

#### 1. To Amend Bylaws, Article IX COMMITTEES, Section C which reads

The purpose of the Native American Grant(s)-in-Aid Committee is to give financial aid for college study of women of <del>American Indian</del> heritage. By Striking American Indian

#### To Read:

The purpose of the Native American Grant(s)-in-Aid Committee is to give financial aid for college study of women of Native American heritage. *Rationale: This change recognized the grant title and accepted language.*

#### Top Ten things to Know About NY's Honorary Member Ruth Colvin

According to our constitution, an honorary member shall be a woman not eligible for active membership who has rendered notable service to education or to women and is elected to honorary membership in recognition of such service. On October 1, 1990, New York bestowed honorary membership on Ruth Colvin, known as the mother of adult literacy.

You ask, just who is Ruth Colvin? What are her accomplishments? With an apology to David Letterman, here is a top ten list of things you should know about our sister Ruth.

10. In 1961 in her home's basement, Ruth Colvin and some neighbors founded Literacy Volunteers of America. She had read something disturbing in The Syracuse Post-Standard - the results of the 1960 U.S. Census. In Syracuse, there were 11,000 people who were functionally illiterate. (Literacy Volunteers of America merged with Laubach Literacy International in 2002. The new organization was dubbed ProLiteracy which served more than 245,000 people last year.)

#### **Finance Committee**

In March 2020, the Finance Committee met and constructed a balanced budget. However, our membership numbers have decreased to the point that either cuts had to be made or dues had to be increased. For the past few years, cuts have been made. We have gone from four printed editions of *Pi Lights* to one. There has been an increased reliance on Go To/Zoom meetings even before the pandemic began. It was decided that to continue making cuts would compromise the ability to function at an acceptable level. Since 2013, there has been a net loss of 689 members of which 277 have passed. This means a decrease in dues income of \$11,280.50.

The Finance Committee is making a motion which will be voted on in the spring. The motion is to have an increase in dues beginning in the 2022-2023 fiscal year. There has not been an increase in dues at the state level in over 20 years. It was felt that a modest dues increase is long overdue. The request is for reserve member dues to increase \$1.50 to \$10.00. Currently the reserve member dues are \$8.50. Active members dues would increase \$3.50 to \$20.00. Currently active member dues are \$16.50. The Finance Committee is mindful that any increase in dues could be a hardship, however, it was felt that this was a very reasonable increase.
