The U.S.E.D. has requested that Connecticut, one of nine states seeking to replace HS assessments with the SAT, provide "substantial" additional evidence showing that the SAT is a suitable HS achievement test. At issue is whether the SAT corresponds with the state's academic standards and whether it provides adequate accommodations for students with disabilities and English-language learners.

Conference committee agree on education spending

A House - Senate conference committee has agreed to set department spending at nearly \$71.5 billion for the upcoming fiscal year 2019 budget. The deal rejects the administration's fiscal 2019 proposal to slash the U.S.E.D. budget, the elimination of several programs, and the creation of school choice initiatives. The agreement must now be approved by both the full House and Senate before heading to the president. Lawmakers did not resolve a dispute over whether schools can use Every Student Succeeds Act grants to pay for firearms and firearms training.

SED plan to punish students and schools with high opt out rates

The state Board of Regents may soon pass new rules for holding school districts and individual schools accountable if too many families "opt out" of tests. One rule would allow the state education commissioner to direct a district to spend a portion of its federal Title I funds on "activities" to increase student participation on state tests...Schools use Title I funds on staff and programs to help disadvantaged students — targeting everything from math and reading intervention to supports for homeless children. AQE accuses NYS of racism in education aid distribution

The education advocacy group Alliance For Quality Education (AQE) release a report highlighting what it describes as racial inequities in the way the state distributes supplementary school aid. The report analyzes "foundation aid" AQE says is owed to districts that are over 50% black and Latino and ranked as "high-need" by the state, and finds that the debt owed to these districts is significantly greater than sums owed to districts that do not meet these criteria. While two-thirds of the districts in NYS overall are owed foundation aid, 100% of high-needs school districts with majority black and Latino students are owed the aid, according to the report's findings. And 62% of the education money owed under current state law is owed to districts that are majority black and Latino. The governor's office has disputed the report's findings.
